7. Handling and storage

Precautions for safe handling

Avoid prolonged and repeated contact with grease, particularly used grease. When working with heated grease, mechanical ventilation may be required. Provide adequate ventilation. Wear appropriate personal protective equipment. Avoid release to the environment. Be aware of potential for surfaces to become slippery. Always remove grease with soap and water or skin cleaning agent, never use organic solvents. Observe good industrial hygiene practices.

Store in tightly closed container. Store away from incompatible materials (see Section 10 of the SDS).
